As we begin the New Year at Sophia Christi we have much to be thankful for as a community. Eight months ago we found our legs and became a legally recognized religious organization in Oregon, and on Friday we completed and sent our application to the IRS to become a recognized tax-exempt non-profit. This foundational work has been the focus of our leadership team this past year, and helps to firmly establish our identity in the formally "structured" world in which we all must exist. Yet who and what we are is not defined by legal papers, financial statements and formal organizational processes. The structures and terminologies of business allow us to function in a world that places a high priority on tracking and regulating numerous social and business transactions. But who we are is the Body of Christ in the world. What we are is a faith community. Our priorities are not those of banks and government offices, but we comply and "render unto Caesar" as Jesus advised us to do. Along the way we build bridges and make friends, like the young banking assistant who bent over backwards to help Leanne and I obtain and file last-minute forms so that Sophia Christi could save \$100 on the IRS filing fee, and the owner of the copy shop who helped us FedEx an overnight letter to the State just in the nick of time so we could meet a paperwork deadline the next day. As we interact with our world we bless it, one person at a time, in banks, copy shops, department and grocery stores. In all these modern-world "stables" we bring gifts to the Christ child from the far-off lands of faith, and we are that Christ child—blessing those who follow Light, then peer closer to see. If you would like to meditate on the readings for our Epiphany Liturgies these next two weekends, they are: Isaiah 60:1-6; Ephesians 3:2-3, 5-6 and Mt 2:1-12.

Community Meetings in January and February

Please mark your calendars for the Community meetings scheduled for next month in **Portland**, on Saturday, **January 21**, from 3:00 to 5:00pm at **Northminster**, downstairs in the dining hall, and in **Eugene**, after Mass, on **February 12**. To prepare for these meetings, allow yourself to envision where you would like Sophia Christi to be five years from now. What do you think our goals should be for 2012? Pastoral Update

In order to qualify for liability insurance (which both First Congregational Church in Eugene and Northminster Presbyterian Church in Portland require of us) we need to have a legal identity as a formal "business" and fit into an IRS tax code category. Our Church partners have been patient and supportive as we've taken time to establish a leadership structure that conforms to State and federal regulations while guaranteeing that we continue to be "governed" by a community committed to listening to Spirit's guidance and direction in its development. How we carry this process of "listening" forward will depend on everyone's participation and input at community meetings and in a host of other ways as we move forward. We can rejoice, however, that at this point we have succeeded in fulfilling our responsibility to Church partners by completing this second leg of the journey toward becoming recognized as an IRS non-profit.

We met our end-of-year deadline for the IRS application thanks to dedicated efforts and loving service from your leadership team, and a bit of last-minute timing assistance from (I'm sure) Sophia herself! My understanding is that contributions to Sophia Christi will become retroactively tax-deductible to the date of our incorporation by the State last April once we receive a confirmation letter from the IRS. Don't hold your breath for 2011 taxes, though, since the government, like the Church, moves veeeryy sloooowly, but we will let you know as soon as we hear anything at all from the Feds.

A pastoral reminder--if you or someone you know has a pastoral need that isn't being met, please feel welcome—always—to give me a call. Look for the basket at the entrance to the sanctuary when you come for Liturgy on Saturday or Sunday, and please be as generous as possible.

Our first Liturgies of this New Year focus our attention on three ancient astrologers who followed a star to the site of Jesus' birth in Bethlehem. These three can represent so many things for us, but they are often seen as "Gentiles", religious "strangers", who—in listening to their hearts and following their inner wisdom—managed to find their way to the Christ child, recognize him as king of the Jews, and trust their dream to avoid Herod and return home by another route. If anyone in Matthew's community holds to the notion that the God of the Jews and Jesus is not the God of ALL people, Matthew lays that notion to rest at the very outset of his Gospel. We, too, follow a star to Bethlehem and receive guidance in our continuing efforts to recognize the Christ child in our own hearts, in the lives and hearts of strangers, and at the very heart, the core reality, of our world. Sometimes we are able to recognize a sense of Divine presence in some person we encounter or in some fleeting experience that graces our day. And sometimes, in those moments, we are awake enough to pause in awe and wonder at the nearness and beauty of our God.

As we embark on this New Year together, accompanied by our Emmanuel, God-with-us, my hope is that all of us take time to notice and acknowledge at least a few of the countless ways Sophia, Christ, the Holy Spirit, our Mother-Father God show up in our daily lives. May we learn to see beneath the surface where peace and love reside, and follow the Light wherever it leads, trusting one another to do the same.
